		RESOLUTION DECLARING THE NECESSITY OF RAISING \$660,000 ANNUALLY FOR SCHOOL DISTRICT PURPOSES

2. BE IT RESOLVED by the Board of Education of the Union-Scioto Local School District, County of Ross, Ohio (the "School District"):

**SECTION 1.** That pursuant to the provisions of Section 5748.02 of the Ohio Revised Code, it is necessary to raise \$660,000 for school district purposes (as defined in Section 5748.01(I) of the Ohio Revised Code), specifically, for general permanent improvements of the School District, including but not limited to, real estate, school facilities, athletic complex (gym), buildings, and personal property and interests in real estate, buildings, and personal property, equipment, furnishings, and site improvements, and reconstruction, rehabilitation, renovation, installation, improvement, enlargement, and extension of property, assets, or improvements so certified as having an estimated life or period of usefulness of five years or more.

**SECTION 2.** That the income that is to be subject to the tax is taxable income of individuals and estates, as defined in division (E)(1)(a) and (2) of Section 5748.01 of the Ohio Revised Code. If the income tax is approved by the electors, such tax shall be effective for a period of Thirty (30) years and the effective date of such tax shall be January 1, 2018.

**SECTION 3.** That pursuant to Section 5748.02 of the Ohio Revised Code and in anticipation of the election to be conducted on May 2, 2017, this board of education hereby applies to the Tax Commissioner of the Ohio Department of Taxation to estimate the property tax rate that would have to be imposed by the School District in the current year to produce the amount set forth in SECTION 1 hereof and to estimate the income tax rate that would have had to have been in effect for the current year as a school district income tax to produce the amount set forth in SECTION 1 hereof.

**SECTION 4.** That the treasurer of this board is hereby directed to certify immediately to the Tax Commissioner of the Ohio Department of Taxation a copy of this resolution.

**SECTION 5.** That it is found and determined that all formal actions of this board of education concerning and relating to the adoption of this resolution were adopted in an open meeting of this board of education, and that all deliberations of this board of education, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the rules of this board of education adopted in accordance therewith.
